

Private Membership Agreement

As a Private Member you understand and agree to select if required from our membership those Private Members who are the most skilled to assist and facilitate the actual performance and delivery of such services and information that is most aligned with your individual and specific needs and that you will make this determination freely and of your own will.

As a Private Member you understand and agree that you have the absolute freedom to make all your health choices and that you are entitled to access information free from censorship in order to make determinations for yourself and where applicable you acknowledge, agree and accept that any choice you make regarding your health and wellbeing is completely your decision, free from coercion or duress and that you make your decisions freely and of your own will.
